## **KEY OPERATING DATA OF 2022 FOURTH QUARTER**

This announcement is made pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) hereby announces the key operating data of 2022 fourth quarter of the Company and its subsidiaries (collectively, the “**Group**”).

### **NEW ENERGY BUSINESS SEGMENT**

According to the Company’s preliminary statistics, the power generation of the Group on a consolidated basis for the 2022 fourth quarter amounted to 4,157,914.49 MWh, representing an increase of 2.18% over the corresponding period of 2021; the on-grid power generation amounted to 4,069,972.40 MWh, representing an increase of 2.46% over the corresponding period of 2021. As of 31 December 2022, the accumulated power generation amounted to 14,198,088.24 MWh, representing an increase of 4.13% over the corresponding period of 2021; the accumulated on-grid power generation amounted to 13,870,533.18 MWh, representing an increase of 4.27% over the corresponding period of 2021. From January to December 2022, the average on-grid tariff (tax exclusive) of the Company was RMB0.45/KWh, representing a decrease of 5.22% over the corresponding period of 2021; the Group’s transacted electricity volume in the electricity market amounted to 3,701,374.57 MWh, the proportion of transacted electricity volume in the electricity market amounted to 26.69%, representing an increase of 16.53 percentage points over the corresponding period of 2021.

## GAS BUSINESS SEGMENT

According to the Company's preliminary statistics, the transmission volume of gas of the Group on a consolidated basis for the 2022 fourth quarter amounted to 1,331,635,500 cubic meters, representing an increase of 10.41% over the corresponding period of 2021, of which, the sales volume of gas amounted to 1,106,447,000 cubic meters, representing an increase of 1.32% over the corresponding period of 2021; the volume of gases transported by the Group for its client amounted to 225,188,500 cubic meters, representing an increase of 97.60% over the corresponding period of 2021. As of 31 December 2022, the accumulated transmission volume of gas amounted to 4,500,762,900 cubic meters, representing an increase of 8.27% over the corresponding period of 2021, of which, sales volume of gas amounted to 3,884,506,900 cubic meters, representing an increase of 2.01% over the corresponding period of 2021, the volume of gases transported by the Group for its client amounted to 616,256,000 cubic meters, representing an increase 76.61% over the corresponding period of 2021.
